# ABOUT US:

Imagine That! is a cooperative association representing local and regional artisans. Our retail store showcases home furnishings and accessories, artwork and crafts of professional quality.

Imagine That! sells consigned goods at 40% commission on gross sales. All work from consignees must be submitted for acceptance by the Jury Committee.

#### **CONSIGNMENT INFORMATION:**

**Step 1**: Before bringing your art to the Jury Committee, ensure you have read both the general criteria and the specific criteria listed under the **JURY CHECKLIST**.

**Step 2**: Complete the Application and Jury Form accompanying this application.

Step 3: Submit work to the store for Jury.

**Step 4**: You will be notified of the Jury decision when all Jury members have had a chance to comment, usually within 10 business days.

## Upon acceptance of artwork:

Artists whose work is accepted by the Jury will be required to pay a registration fee of \$25. plus taxes to Imagine That! before any artwork can be submitted for sale or sold in the store.

Imagine That! relies on the participation of many of our artists in the day to day running of the store. Artists who have a team player attitude and would like to explore working in the store please inquire with us. If we think you would be a good fit we will provide training on our sales procedures and operations. Among the many benefits of helping in the store, volunteering a minimum of one full day or two half-days per month artists receive a reduced consignment percentage.

### **JURY CHECKLIST:**

#### General Criteria:

The Jury will consider your presentation and workmanship, finishing, pricing and sale-ability, originality, and consistency of quality. The Jury will also consider the availability of display space in the store and are looking for items that are different from stock already sold in the store.

- Any packaging accompanying the art must be retailpurpose made packaging. For example, cards must be in purpose-made fitted sleeves, not zippered freezer bags
- Jewelry uses quality findings and is displayed on cards or boxed
- Pottery has smooth bottoms
- Paintings hanging-ready with appropriate hardware
- Prints/Photos marked with method of reproduction
- Sculpture ready to display with felt pads

Non-acceptance should not be taken personally as there are many reasons for the Jury Committee to decline your work. A critique of your work will **not** be given.
